

## PUBLIC NOTICE OF PROPOSED ADOPTION OF AMENDMENTS TO CPA RULES AND REGULATIONS

The Commonwealth Ports Authority, pursuant to the authority of Section 4(4) of Public Law No. 2-48, and in accordance with the provisions of Section 4(1) of Title 17 of the Trust Territory Code, hereby gives notice to the public of its intention to adopt amendments to its regulations concerning the following: dockage surcharges and port security. The proposed amendments are published herewith.

All interested persons will be given a reasonable opportunity to submit data, views, or arguments, in writing, concerning the proposal regulations. Written comments must be submitted to the Executive Director, Commonwealth Ports Authority, not later than the close of business thirty (30) calendar days following the date of publication of this Notice.

1. Paragraph D of Part V of the Terminal Tariff is hereby amended by the addition of the following:

"In addition to the foregoing dockage rates, vessels which are principally engaged in the catching and transshipment of tuna and other related species shall pay a surcharge for dockage, computed as follows: for catch vessels, \$200.00 per 24-hour day or fraction thereof for each day after the first ten (10) days of a continuous dockage period; and for motherships, \$200.00 per 24-hour day or fraction thereof for each day after the first 21 days of a continuous dockage period. For the purposes of this paragraph, a dockage period shall not be construed as ending unless and until a vessel shall have vacated its berth or slip for a period of not less than 24 consecutive hours."

2. There is hereby added a new Part 3.36 to the Harbor Regulations, to read as follows:

"3.36. PORT SECURITY.

"Whenever, in the opinion of the Port Superintendent, the activities of a vessel in port, or of its crew, so warrant, the Port Superintendent may engage the services of such security personnel as he deems reasonably necessary to maintain peace and order upon a CPA dock or wharf, and to guard against violations of Commonwealth laws or regulations. Upon so doing, the Port Superintendent

shall promptly notify the master or agent of the vessel concerned. The vessel and its owners shall be liable to CPA for CPA's actual cost of such additional security personnel, plus 10% of such cost for administrative expenses. The master or owners of the vessel may appeal in writing, within ten days of such determination, any determination made by the Port Superintendent under this Paragraph to the Board of Directors of CPA, which shall promptly afford to the master or owners notice of and the opportunity to be heard at a hearing, conducted in accordance with the provisions of Title 17 of the Trust Territory Code."

The proposed policies include the following subject areas:


1. student transportation

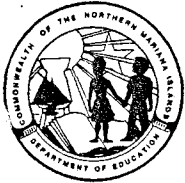

COMPENSATION

Policy 206 - Compensation. Members of the Board shall receive an honorarium at a reasonable rate set by the Board. Members shall be reimbursed for reasonable and necessary expense incurred in the performance of their duties, to the extent that funds are available.

CHARTER OF NON-PUBLIC SCHOOLS

Policy 309.1 In accordance with P.L. 3-43, an application for a charter to operate a non-public school or educational program shall include, as the criteria for approval, the following information:

1. Name of applicant and school or program
2. Proposed location of school or program
3. Proposed language and course of instruction
4. Summary of financing
5. Purposes of the school
6. Enrollment requirements
7. Auspices under which the school program will operate
8. Description and qualifications of faculty members and School Administrator
9. Dates and hours of operation
10. Agree to provide the Board with an annual report summarizing the year's activities.

309.2 The application must also contain certification by Public Works and Public Health that the premises are safe and sanitary.

309.3 If the application for a charter is for a school, that application must contain the following assurances:

1. Each student will receive 300 minutes daily of secular instruction.
2. School personnel will receive periodic examination to assure that they are free of active tuberculosis.
3. The school year will encompass a minimum of 180 full days of instruction.

309.4 The life of a charter shall be three years. However, the Board, after notice and opportunity for hearing, may suspend or revoke the charter of any non-public school if in its judgment the holder has violated the the terms of the charter or is otherwise not providing the education requested by its charter.

STUDENT TRANSPORTATION

- Policy 310.1 Students living a distance greater than 1.5 miles from their school of attendance shall receive free public transportation, as resources permit. Nothing in this policy shall be construed to prevent students from receiving free public transportation if they live less than 1.5 miles from their school and the resources are available.
- 310.2 Non-public schools requesting bussing services shall follow the scheduling and rules governing bussing by the Department.
- 310.3 The Department is not responsible or liable for accidents occurring to, from, or on school campus as a result of the use of private vehicles (cars, mopeds, motorcycles, or bicycles) by students.

EDUCATION & TRAINING LEAVE

- Policy 505.2
- a. The Superintendent shall recommend to the Personnel Officer Education and Training Leave for employees of the Department of Education, to the extent that funds are available for such purpose, in accordance with the following criteria, which are listed in the order of their precedence:
    - (1) The extent to which the employee's proposed course of study will meet the present and future needs of the Department of Education;
    - (2) The need for continuing education to enable the employee to maintain currency with his or her field of endeavor;
    - (3) The employee's nearness to the completion of degree requirements; and
    - (4) The employee's performance of his or her duties with the Department of Education (in this connection, the Superintendent shall take into a consideration all factors bearing upon performance, including but not limited to past personnel evaluations);
  - b. Upon the recommendation of the Superintendent, Education and Training Leave may be extended by the Personnel Officer.
  - c. An employee who is in the status of Education and Training Leave shall be entitled to benefits as provided by the Personnel Service System Rules and Regulations.
  - d. An employee who is on Education and Training Leave is expected to be a full time student at the institution which he or she attends. For this purpose, employees shall carry a minimum full-time load as defined by the institution. The employee is also expected to maintain a minimum grade point average for their academic grade level as required by the institution.
  - e. The Superintendent shall require each employee to meet certain reporting requirements concerning her or his course of study and her or his performance therein. Any employee who fails to comply with such reporting requirements shall be placed on leave status, and shall not be entitled to reinstatement of Education and

Training Leave status unless and until such requirements are complied with. Any employee who, while on Education and Training Leave status, fails to comply with the conditions under which such leave was granted, shall be placed upon Annual Leave status or Leave Without Pay status, as appropriate, retroactive to the date when such employee was placed on Education and Training Leave.

- f. Every employee who is on Education and Training Leave status shall cause to be sent to the Superintendent of Education a certification of her or his participation in the course of study attended, which certification shall indicate the number of credits carried, if applicable. Within thirty (30) days after completion of every grading period while the employee is on such status, transcripts of the grades received and courses taken must be submitted to the Superintendent.
- g. Failure to comply with these conditions herein may be the basis for the revocation of the Education and Training Leave status. In the event that Education and Training Leave is revoked, the employee will reimburse the government for government incurred expenses while on such leave.
