ORDER APPOINTING JUDGE *PRO TEMPORE*

¶ 1 Presiding Judge Roberto C. Naraja has informed the Court that the sitting judges in the Superior Court have recused themselves from the above-referenced matter. Under the authority of Article IV, Section 9(d) of the Northern Mariana Islands Constitution and in furtherance of the prompt and efficient dispatch of Court business, the Chief Justice may designate a judge *pro tempore* as necessary.

¶ 2 IT IS THEREFORE, ORDERED:

- a. David A. Wiseman, former Associate Judge of the Commonwealth Superior Court, is hereby designated and appointed to serve as judge *pro tempore* in this matter.

b. Parties shall notify the Clerk of the Superior Court in writing no later than 10 days from the date of this ORDER of any good cause or reason why David A. Wiseman should not serve as judge *pro tempore*.

¶ 3 Unless good cause be shown otherwise, Judge *Pro Tempore* David A. Wiseman shall have full authority to serve in this matter and shall carry out the duties and power inherent with the appointment.
